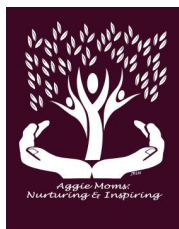

Form T – Due February 1, 2018

Each year we ask that you coordinate with your treasurer to provide information about your club that the Federation needs to keep our records up-to-date with the IRS. Most of our 108 Aggie Mom clubs have exemption from Federal income tax through the Federation's determination as a 501(c)(3) organization. As the parent tax-exempt organization, the Federation is required to furnish the IRS with a complete listing of subordinate groups – our local clubs – each year. We collect current information about each club through our Form T. The Form T is for Federation internal record keeping only. Form T is not filed with the IRS. Returning the Form T to the Federation does not exempt your club from filing a Form 990 each year with the IRS. See the Federation website, www.aggie moms.org, for the current Form T and a cover letter regarding the Form T. **To ensure that your club remains covered under the Federation exemption, please provide ALL of the information requested on Form T.** The Federation's group exemption filing is due to the IRS by the end of March every year. In order for us to complete our required filing in a timely manner, please complete your Form T and remit it to Peggy Nolan, 3963 Goodfellow Dr., Dallas, TX 75229 no later than February 1, 2018. Form T information may also be scanned and emailed to Peggy Nolan at preselect@aggienetwork.com. Failure to return a Form T could result in your club's removal from the Federation group exemption. ATTENTION: Please make note of important dates related to Federation dues, archive fees and the filing of your club's Form B. If your Club is part of the IRS exemption Group (umbrella), dues must be postmarked no later than February 1, 2018.

REMINDER: Form B is posted on the Federation website along with an instruction sheet. Please read the instructions carefully and send Form B and a check for your dues and archives fees made out to the Federation of Texas A&M University Mothers' Clubs.

Form B and your club's check are sent to the Federation Treasurer, Cathleen Inman.

Remember: Your club's Form B and the check for dues and Archive fees must be postmarked by February 1, 2018. If it is postmarked after February 1, 2018, there are late fees. See the Form B instruction sheet for details. Dues not paid by May 31, 2018 will result in your club being considered inactive.

Howdy Aggie Moms:

You have survived the Fall Semester and it will soon feel like you are about to slam into Summer again. By Winter Meeting, most of you have some idea of what your club does and what your officer position duties are. It is a great time to ask questions and ask for help...and then ask more questions.

My Parliamentarian Project for this year is to obtain a **digital copy of current Club Bylaws & Standing Rules for EVERY club**. Federation maintains copies of every set of bylaws in their files (and paper files can get a little cumbersome). I'm trying to digitize everything for convenience sake. You may send them to me at parl@aggienetwork.com. I have received about 25% at this point. Initial review of those bylaws has shown that reviews and updates are definitely needed to be brought into compliance with Federation Bylaws. I also have found that many clubs do not even know where their bylaws documents are...and cannot consult them. Never fear! I do have hard copies of them, so please ask if you need them. My Winter Workshop, **"Bylaws 101: The Down & Dirty of Getting Them Right"** will offer the format that your club bylaws must follow and why (forms will be posted on-line). So, please come to the workshop on the "Down & Dirty" to get your club back on track. It really isn't as daunting as you may think.

As you make plans to visit Aggieland for Winter Meetings, please review how our Business Meetings work.

- Only designated voting delegates will be eligible to vote.
- Each club has at least 3 Delegates (the Club President, or designee, and two active-paid members) to represent their first 100 members. For those clubs with more than 100 members, the club receives 1 additional delegate for every 50 members. **The List of Voting Delegate Numbers** for the year, as well as the **Delegate Submission Form** are posted on the website under **Federation Documents** for your convenience.
- Confirm the number of delegates for your club.
- **Submit delegate names to Risha Sanders** at 3rdVPRegistration@AggieNetwork.com by **January 15**. As we did with past meetings, there will be designated seating for the voting delegates. All other members and guests will be asked to sit in the unmarked sections of the room.

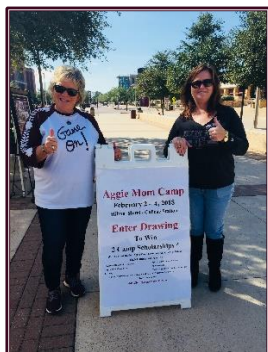
