Howdy again Moms! Form T - Due February 1, 2019

Each year we are required to update our records with the IRS concerning our subordinate clubs. To comply with this **IRS requirement**, we ask you to work with your Treasurer to provide your club's information. All 108 Aggie Mom clubs have exemption from Federal income tax through the Federation's determination as a 501(c)(3) organization.

As the parent tax-exempt organization, the Federation is required to furnish the IRS with a complete listing of subordinate groups – our local clubs – each year. We do this by collecting current information on all our clubs through the Form T. The Form T is for Federation internal record keeping only. Form T is not filed with the IRS. *Please note returning the Form T to the Federation does not exempt your club from filing a Form 990 each year with the IRS*. The current Form T and a cover letter regarding the Form T is located on the Federation website at https://aggiemoms.org/forms/formt/.

To ensure that your club remains covered under the Federation exemption, please provide ALL information requested on Form T. The Federation's group exemption filing is due to the IRS by the end of February every year. So that we may complete our required filing in a timely manner, please complete your Form T and remit it to Cathleen Inman, PO Box 1723, Blanco, TX 78606 no later than **February 1, 2019**. Form T information may also be scanned and emailed to Cathleen Inman at preselect@aggienetwork.com. Failure to return a Form T could result in your club's removal from the Federation group exemption. You may access Form T directly at: http://aggiemoms.aggienetwork.com/forms/formt.




Plan to attend the Treasurer's Workshop at the Winter Federation Meeting and Workshops on January 26, 2019. There will be a Sales Tax Information update, along with help Navigating Form B (Dues & Archive Fees), Form Y (Tax Compliance), Form E (Donations) and Form G (Scholarships).

Reminder: Annual Sales Tax Reports are due to the State Comptroller on **January 22**, **2019**. For more information on completing your club's sales tax report, check out the handout from the Fall Workshop Sales Tax presentation online at www.aggiemoms.org.

Club dues and archive fees, along with Form B, must be postmarked by **February 1, 2019**. Form B and an instruction sheet can be found on the Federation website at www.aggiemoms.org/forms. <u>Dues paid after February 1st will incur a late fee, and dues not paid by May 31st will result in your club being considered inactive</u>. Dues must be postmarked by February 1st in order for a member of your club to be eligible for a Federation Officer position.

Pearls of Wisdom from the Parliamentarian

Howdy Aggie Moms:

You have survived the Fall Semester and it will soon feel like you are about to slam into Summer again. By Winter Meeting, most of you have some idea of what your club does and what your officer position duties are. It is a great time to ask questions and ask for help...and then ask more questions.

Our **Parliamentarian Project** for the past two years is to obtain a digital copy of current Club Bylaws & Standing Rules for EVERY club. If you did not send a copy in 2017-2018 or your Bylaws have changed since then, please send a <u>complete digital Word</u> document copy of your current bylaws and standing rules to <u>parl@aggienetwork.com</u>. Federation maintains copies of every set of club bylaws in their files and 108 sets of paper files can get a little cumbersome.

We are trying to digitize everything for convenience sake. Specific areas of review will be sections pertaining to Membership criteria, Delegate selection, Restrictive Clause, and Dissolution. The Federation is the parent organization, and as such, establishes those criteria for all chapter clubs to follow. If you feel that your chapter club by-laws may not be in line with those of the Federation parent organization, please do not hesitate to ask for help or email me with questions.

An IMPORTANT additional request – please send your Scholarship Guidelines, how these are approved, including selection of Committee and selection of recipients, etc. It is very important that everyone understands that Scholarship applications must be announced publicly in all zip codes that your club members represent including Adopt a Moms, cannot be restricted to only club members' students, members cannot "earn points" that apply to their students receiving a scholarship, that the members of the Selection Committee cannot review a pool of applicants of which their student is one, and if at all possible, NAMES/identifiers of the applicants should be blacked out or redacted before distribution to the members of the Scholarship Committee with a non-personal identifier used.

As you make plans to visit Aggieland for Winter Meetings, please review how our Business Meetings work.

- Only designated voting delegates will be eligible to vote.
- Each club has at least 3 Delegates (the Club President, or designee, and two active-paid members) to represent their first 100 members. For those clubs with more than 100 members, the club receives 1 additional delegate for every 50 members. The List of Voting Delegate Numbers for the year, as well as the Delegate Submission Form are posted on the website under Federation Documents for your convenience.
- Confirm the number of delegates for your club.
- Submit delegate names to Kim Kovar, the 3rdVPRegistration@AggieNetwork.com by January 23. As we did with past meetings, there will be designated seating for the voting delegates. All other members and guests will be asked to sit in the unmarked sections of the room.




