- Your club's 2019 - 2020 dues and Archive Fee must be paid by the February 1, 2020 deadline for you to be eligible to apply.
- You are expected to attend the Summer Workshop in June, the three Federation Meetings, one in August, January, and on Family Weekend in April, and the Board Meetings on the day before the Federation Meetings.
